- Attendance, Convened and Adjourned. - Quorum and Notice Verified and Minutes: A quorum was established and proper notice verified. The Minutes from the January 17, 2017 meeting were unanimously approved and adopted.
- 3. <u>Business Conducted</u> (Unless otherwise noted, all business conducted received unanimous vote from the Board.)
 - **a.** <u>Website:</u> The changes requested by Treasurer Duane Busa at the January 17th meeting were made to the website;
 - **b.** Fining Committee. 1. Robert Kelly has notified Jimmy at LaRouse landscapers and Lowes painters of these items. New "pick up after your dog" signs and a left over Seminole Towing sign will be replaced.

- **e.** <u>Zinsco Breakers.</u> Property Manager Robert Kelly still in process of obtaining quotes from electricians regarding Zinsco breaker replacement;
- **f.** <u>Letter Re: Garbage Collection Times</u>. Property Manager Robert Kelly drafted and the Board approved a letter for mailing to co-owners and tenants regarding placing garbage at curb on collection day and not days before collection day. This letter also contained information about the association's central email.
