Comments: The year of construction was verified as 1980 per Pinellas County Property Appraiser.

Comments: The roof covering was replaced in 2009. The roof permit was confirmed and the permit number is PER-H-CB09-04320. This roof was verified as meeting the building code requirements outlined on the mitigation affidavit.
